### WORLD TOILET DAY 2024 Celebrating Sanitation as a Foundation for Peace



On November 19. 2024, we joined hands with key partners the Uasin Gishu **County Government**, Fresh Life Initiative, and Water & Sanitation for the Urban Poor (WSUP) to mark World Toilet Day under the global theme "Toilets: A Place for Peace." This year's celebration shed light on the vital role of resilient sanitation systems in fostering health, dignity, and stability in vulnerable communities.

ELDOWAS has established itself as a leader in providing sustainable and inclusive sanitation services to all residents of Eldoret and its environs. Through strategic partnerships with Fresh Life Initiative and WSUP, the company has expanded access to sanitation for underserved populations in informal settlements.

• Fresh Life Initiative (FLI): This collaboration focuses on non-sewered sanitation solutions tailored to informal settlements. FLI has implemented innovative technologies, such as portable toilets and manual emptying services, ensuring safe containment and disposal of human waste. Joint projects like "Mtaa Fresh" tackle pit waste management by establishing localized discharge points, significantly reducing pollution in local rivers.

• Water & Sanitation for the Urban Poor (WSUP): Together with ELDOWAS, WSUP enhances the capacity of sanitation service providers, introduces efficient technologies, and develops sustainable business models for sanitation services in lowincome areas. This partnership also strengthens institutional frameworks to support ELDOWAS's ambitious sanitation goals.

Up-scaling Basic Sanitation for the Urban Poor (UBSUP) is a transformative initiative designed to provide sustainable sanitation solutions to low-income urban communities in Kenya





"From makeshift to modern: A glimpse of transformation through UBSUP. Before, an unsafe and unhygienic structure; after, a safe, eco-friendly, and dignified sanitation facility.

As part of its mandate to provide equitable sanitation services, **ELDOWAS** is currently implementing the **Upscaling Basic** Sanitation for the Urban Poor (UBSUP) project in Langas. Funded by the Water Sector Trust Fund (WSTF) and the Bill & Melinda Gates Foundation, this project aims to provide over 300 households with safe and affordable sanitation facilities.

The UBSUP initiative follows a demand-driven approach, with households contributing to the construction costs while receiving subsidies for toilet installations. The project also integrates comprehensive waste management systems, including decentralized treatment facilities to process and recycle sludge into biogas and other resources.



ELDOWAS's sanitation initiatives directly contribute to Sustainable Development Goal 6. Key achievements include:


- Improved sanitation access: Thousands of residents in informal settlements now benefit from hygienic and sustainable sanitation solutions.
- Environmental preservation: Projects like "Mtaa Fresh" have drastically reduced open defecation and contamination of water sources.
- Capacity building: ELDOWAS and its partners have trained local entrepreneurs and community members in managing and maintaining sanitation systems.

#### **INTERRUPTION OF WATER SUPPLY FROM CHEBARA WATER TREATMENT PLANT.**

This is to inform you that the water supply from the Chebara Treatment Plant will be temporarily interrupted. The interruption will begin on **Wednesday, December 4th, 2024,** at **9:00 a.m**. and continue until **Thursday, December 5th, 2024,** at **9:00 p.m**. The interruption is to facilitate essential routine maintenance. The areas which will be affected include:

- Kimumu, University of Eldoret and their environs
- Marakwet farm, Kapchumba, the upper parts of Maili-nne and their environs
- Munyaka, Kapsoya, Action estates and their environs.
- Rift Valley Bottlers, Bio-Corn and their environs
- Upper Elgon View, Eldoret Polytechnic, Annex, Langas, Racecourse, Kapseret and their environs.
- Chepkanga, Marura and their environs.
- Kamukunji, Mwanzo, Old Uganda Road and their environs.
- All the customers along the Chebara-Eldoret Pipeline.

During this period, the water bowser services will also be unavailable, however, the other water treatment plants will remain operational to ensure the continuity of water supply to unaffected areas.



# TARIFF REVIEW & IMPLEMENTATION PROCESS





#### WHAT IS IT?

Justified price charged on water service to cover reasonable cost of providing the service

#### **OBJECTIVES OF A TARIFF REVIEW**

- Ensure financial sustainability.
- Foster access to Safe Water as a Human Right
- Promote efficiency in the delivery of water services.
- Encourage conservation.
- Ensure simplicity in the pricing structure of water.

#### TARIFF ADJUSTMENT/APPLICATION PROCESS

Six months before the expiry of our tariff on 30th June 2024 :

- ELDOWAS submitted a tariff review application proposal to WASREB.
- WASREB screened the application for completeness and sufficiency.
- The application was assessed for cost justification, projection realism and affordability.
- WASREB conducted a physical verification of proposed investments.
- ELDOWAS and WASREB held a negotiation meeting in March 2024 to discuss the proposed tariff.
- WASREB informed ELDOWAS and the county government of the outcome of the negotiation and the proposed tariff structure.
- WASREB and ELDOWAS conducted public participation on the proposed tariff with its stakeholders in May 2024 to gather feedback on the proposed tariff.
- WASREB's Board of Directors reviewed and approved the proposed tariff.
- WASREB published the approved tariff in the Kenya Gazette, on 4th October 2024
- ELDOWAS issued a 30-day public notice period for the implementation of the tariff on 7th October 2024

#### THE TARIFF REVIEW PROCESS IS NECESSITATED BY THE FOLLOWING FACTORS:

- Dependence on subsidies which has become unsustainable.
- Expiry of the 5year Tariff on 30th June 2024
- Continued rise in the cost of water production
- Financial sustainability

#### APPLICABLE PRICING MODEL

The tariff (T) (price) of water is based on a cost-recovery model, whereby the tariff to be paid by consumers is adequate to cover the justified costs of the water service provider.

T = O + M + DS + I + AR

- Where: **O** = Operations Component
  - M = Maintenance Component
  - DS = Debt Service Component
  - I = Investment Component
  - AR = Asset Renewal Component

#### BENEFITS OF A NEW WATER TARIFF

New water tariffs are implemented to enhance the efficiency and sustainability of water service provision. This involves increasing coverage, improving supply hours, reducing water loss and ensuring the financial viability of water service providers.

Key benefits of a new water tariff include:

- Increased coverage, reduced rationing and improved water quality.
- Enables water service providers to meet operational costs, repay debts and invest in infrastructure.
- Funds for upgrading and expanding water distribution networks.
- Ensures that the cost of providing water services is fairly distributed among consumers.

While new tariffs may increase consumers' costs, they are essential for ensuring a reliable and sustainable water supply in the future.

#### HOW MUCH DOES 1 UNIT COST?

1 unit is equivalent to 1,000 litres which is charged Ksh. 130. Meaning 1 litre is Ksh. 0.13 and 20lts is Ksh. 2.60
